# a. Eligibility and Revised Applications for Dial-A-Ride

# b. Reduced Student Fares

Background: See Rider's Guide, above

**Motion:** The Advisory Committee recommends to the CCATD Board of Directors to institute a reduced student fare at ½ price for deviated fixed routes and intercity routes and a \$2 fare for student dial-a-ride.

## c. Adjusted Fare on the Roseburg Intercity Route

Background: Currently the Roseburg route is twice as many miles as the Florence route while the Roseburg full fare is \$8 compared to Florence at \$12. The proposed change is an incremental step to realigning the fares and cost per mile. The proposed motion will adjust the full fare for Roseburg to \$12 one-way.

**Motion:** The Advisory Committee recommends to the CCATD Board of Directors to adjust the Roseburg full fare from \$4/county to \$6/county as an initial step in closing the disproportionate relationship between the fare and cost per mile.
