a. RFP Coordinated Human Services Plan Update

Motion: Director Taylor moved to award Nelson\Nygard Consulting Associates a contract from CCATD not to exceed \$60,000. Director Johnson seconded. Passed unanimously.

b. Fare Ordinance First Reading

The Ordinance previously passed in June has been problematic to operationalize when it comes to the intercity routes. It is necessary to present the intercity fares in a format that can more easily be understood and applied by both staff and the public.

Motion: Director Long moved to approve the first reading of the fare ordinance 21-02. Director Taylor seconded. Passed unanimously.

c. Resolution Rider's Guide DAR Eligibility

The District received an application for Dial-A-Ride service in Bandon who is neither an elder, nor has a disability or health condition, nor a student. By policy it would be necessary to deny this individual's application; however, services are greatly under-utilized in Bandon at this time while alternative transportation is limited to none.

Motion: Director Johnson moved to adopt Resolution 2021-6 adding Limited General Public Dial-A-Ride Service. Director Irvin seconded. Passed unanimously.

- a. Recruitment for Planner Update:
 Candidates are still being sought out for this position
- b. Veteran's Day Reminder: CCATD will be operating 2 services on Veterans Day. Dial-A-Ride for medical and employment transportation, and the Florence Express route.

12. CITIZEN COMMENTS ON NON-AGENDA ITEMS -

Jennifer Boardman gave an NTD update, a few issues were found, and a list will be emailed out for resolution. ODOT submitted a 5339 Federal grant that included CCATD's request for two buses. Competition is very high for these grants and the likelihood for award is low. Another State grant funding cycle is coming around in January which may be more attainable.
