II. Consent Agenda

III. Managers' Update

A. Operational/Administrative Update

The Board of Commissioners formally appointed members of the Coos County Public Transit System Advisory Committee. You are now public officials, Welcome members! Sergio let everyone know that if they did not have a signed copy of the bylaws he would gladly send them via email if needed.

CCAT still has a requisition out for a Road Supervisor, this is a full time position with benefits. This person must have some managerial experience a class B CDL and a passenger endorsement. Sergio may have a couple of interviews by the end of the month. Sergio reported that they did some charter service reporting to ODOT, they provided service twice for them. The first was to the Port of Coos Bay transporting Caddy McKeown and other Legislatures. The second was providing service to folks to the Vietnam Traveling Wall. The NTD (National Transit Database) report was turned in on the 12th of this month, this report is on the fleet and revenue, and assets.

B. STIF Update

The Committee went over the master STIF budget spreadsheet line by line, topics included personnel costs, infrastructure, operational expenses and special projects. CCAT is looking to update their GPS tracking systems for the fleet, this will help immensely. New services are en route for CCAT as they are looking at opening their bus doors on Saturdays in 2019! Sergio is working on making CCAT more competitive and looking to recruit and maintain quality employees. The Trolley bus is seasonal and will operate until the end of October and will open again in May 2019. Sergio is still working on the Regional Transit HUB, I'm sure we will have updates as this moves along.
